4. All the participating Ministries/ Departments/ Organisations are requested to invite objections/ suggestions, if any, from the officers and examine the same. Thereafter, they may send a consolidated response to this Department within a period of **15 days** from the date of issue of this OM and latest by 07.10.2022. Objections/ suggestions received after this period will not be entertained.
