<u>Guidelines approved for the Training Programme on "Project Appraisal and Risk Management"</u>

I. Minimum Service:

The officer should not have attended any Foreign Training/Conferences /Workshops/Seminars abroad of duration of more than two week (excluding travel time) during the last two years.

V. Departmental proceedings:

The officer should not have any departmental proceedings/Vigilance cases pending or contemplated against him/her.

VI. Preference would be given to those IES officers who are currently holding cadre posts.
