OFFICE MEMORANDUM

Subject: Mandatory Mid-Career Training Program Phase-II (MCTP-II) for Senior IES Officers with IIM-Bengaluru from 14th September to 2nd October 2015 including 1 week Overseas Learning Component (OLC) with University of Maryland - Robert H Smith School of Business (UMD-Smith), USA from 28th September to 2nd October, 2015 – Nomination reg.

The IES Division, Department of Economic Affairs, being the Cadre Controlling Authority of the Indian Economic Service (IES) nominates 20 Senior IES Officers and Shri Deepak Rao, Deputy Director, IES Cadre, Department of Economic Affairs for the Mandatory Mid-Career Training Program Phase II (MCTP-II) to be conducted by Indian Institute of Management, Bengaluru (IIM-B) from 14th September to 2nd October 2015. The training program comprises 2 weeks of Domestic Learning Component (DLC) at IIM-B from 14th to 25th September, 2015 and 1 week of Overseas Learning Component (OLC) with University of Maryland - Robert H Smith School of Business (UMD-Smith), USA from 28th September to 2nd October, 2015 (excluding journey time).

3) It is requested that the officers may be relieved by the Ministry/Department/Organization concerned to enable them to attend the Mandatory Mid-Career Training Programme (MCTP-II) from **14th September to 2nd October 2015** (excluding journey time).

In addition, the Ministry of External Affairs has conveyed its 'No Objection' from the political angle (vide OM No. AA/122/03/2015-316 dated 13.08.2015) to the visit of 20+1 IES Officers to the U.S.A. from 28th September to 2nd October, 2015 (excluding journey time) for attending 1 week Overseas Learning Component (OLC) with University of Maryland - Robert H Smith School of Business (UMD-Smith), U.S.A.

5) The approval of Screening Committee of Secretaries (SCOS) has been received vide MoF (Exp.) ID Note No. DC-265358/E.Coord-2015 dated 01.09.2015.

6) The entire cost of the training (including the cost on account of international travel, accommodation and foreign daily allowance) will be borne by the IES Cadre, Department of Economic Affairs. However, only TA/DA of the nominated officers, as applicable, for to and fro travel to Delhi Airport; and for air travel from Delhi to Bengaluru & back is required to be borne by the respective Ministry/Department/Organization.


7) It is mentioned that the training program comes with a lot of effort on the part of IES Cadre as well as cost to the Government. It also entails advance planning in terms of tying up with foreign/domestic partner institutions and faculty resources, apart from handling the logistics connected with foreign visits etc. Hence, it is

requested that the nominated officers may be relieved in time so as to avoid last minute cancellations which would cause loss to the Government exchequer and raise audit objections.

8) The Ministry/Department/Organization concerned and also the nominated officers are requested to confirm their participation for the training programme, **latest by 4th September, 2015** to the IES Cadre, Department of Economic Affairs.

9) The deputation order for respective officers for the duration of the training may be issued by the Ministry/Department/Organization concerned, with a copy marked to IES Cadre Management Division, DEA.
