OFFICE MEMORANDUM

Subject: Mid-Career Training Program Phase II (MCTP-II) for IES Officers with IIM-Bengaluru.

The next mandatory Mid-Career Training Program (MCTP) Phase-II (as per revised MCTP scheme of DoPT) for IES Officers is being organized at IIM-Bengaluru from 11^{th} September, 2016 to 9^{th} October, 2016. The duration of the training program will be four weeks, comprising three weeks of Domestic Learning Component ($11^{th} - 30^{th}$ September, 2016) and one week of Overseas Learning Component ($2^{nd} - 9^{th}$ October, 2016).

- 2. The MCTP Phase-II (as per revised MCTP scheme of DoPT) is for Officers of 14-16 years of service seniority. On this basis, during the current year, Phase II will cover Batches from 2000 to 2002. Since the IES Cadre has already nominated Batches up to 2004 under the MCTP Phase I (which is now MCTP-II according to DoPT's revised MCTP guidelines), the IES Cadre is giving a last opportunity to Officers from Batches up to 2002 who could not attend MCTP Phase-I (of IES Cadre) in the previous years, to attend the MCTP Phase II. Accordingly, the list of the Officers who could not attend MCTP Phase I in the previous years is **enclosed.**
- 3. The entire cost of the training (including the cost on account of international travel, accommodation and foreign daily allowance) will be borne by the IES Cadre, Department of Economic Affairs. However, TA/DA of the nominated officers, including to and fro travel to airport within India and air travel from place of posting of individual officers to Bengaluru and back, is to be borne by the respective Ministry/Department/Organization.
- 4. It may be noted that the MCTP is a mandatory Program for IES officers, as per DOPT guidelines. Further, it entails detailed and advance planning by the Cadre authorities in tying up with partner institutions and faculty resources etc., and also involves considerable financial commitments. Hence, timely release of the Officers nominated for MCTP by the respective Ministries/Departments/Organizations is essential. The Administrative Ministries/Departments/Organizations are, therefore, requested to ensure that the officers are released in time, without fail.
- 5.
