IES Cadre being the Cadre Controlling Authority for the officers of the Indian Economic Service (IES) intends to conduct a One week 'Workshop on Commodity Markets and Macro Economy' with National Institute of Securities Market (NISM), Mumbai during 25<sup>th</sup> – 29<sup>th</sup> July, 2022.

2. This workshop is likely to help participants understand various commodities of economic significance to India, benchmark spot and futures markets and prices, economic data releases and their implications, ways to interpret the price signals, Price Reporting Agencies and their increasing role in enabling commodity transactions and its relevance to policymaking. It will impart training on using the Bloomberg terminal for accessing the futures prices, as well.
3. The IES Cadre will bear the tuition fee and the cost of accommodation. However, TA/DA, as applicable to individual officers, will have to be borne by the concerned Ministry/Department/Organization where the officers are posted.

The Course strength is of 30 officers and received applications will be evaluated basis the relevance of the course to officers and their performance in present/past postings, prior to final selection for undertaking the training.
