2. It is clarified that IES Cadre will bear the Programme fee and the cost of accommodation. The TA/DA of the nominated officers, as applicable, for travel from Delhi/place of posting to IIM, Kozhikode, and back is required to be borne by the respective Ministry/Department/Organization as per extant rules. It is further clarified that the IES Cadre will not be arranging for any pick/drop facility from the airport/railway station. Officers will need to arrange for their own travel as per the entitlement and obtain the required reimbursement from their respective Ministry/Department/Organisation.
