The Department of Economic Affairs (IES Division), Cadre Controlling Authority of the IES, would bear the programme fee, cost of accommodation, airfare to and fro New Delhi-Singapore (*economy class*) and cost of per diem allowance as admissible under the rules. However, domestic TA/DA of the nominated officers is required to be borne by the respective Ministry/Department/Organization.

3. Embassy of India, Singapore is requested to arrange for hotel accommodation for the officers during their stay in Singapore. The other entitlements of the officers including medical assistance will be as laid down in the Ministry of Finance O.M. No.A 19036/7/83-E.IV dt. 7.11.1984 as amended from time to time.

4. The entire expenditure to be incurred on the above mentioned training will be debitable to Major Head "3475" Minor Head "00.800-Other Expenditure, Sub Head "07.00.50"-Training of IES Officers in Demand No.32 of Department of Economic Affairs for the year 2011-12.

5. It is requested that the nominated officers may be relieved to enable them to attend the training programme on **"Public Governance and Economic Development: Singapore's Experience and lessons for India"** to be held from 5th-9th March, 2012 at Civil Services College, Singapore. On return to India the officers would submit a report (in duplicate) on their participation in the above event within a fortnight of their return to India.

6. The Ministry/Department/Organization concerned as also the nominated officers may kindly confirm their participation for the training programme, *positively by 21.2.2012* to the IES Cadre, Department of Economic Affairs so as to enable this Department to book the air tickets and to seek political clearance from Ministry of External Affairs. *If confirmation regarding participation is not received by the date indicated above, it will be presumed that the officer will not participate in the said programme and the nomination of the officer would be cancelled.* The necessary deputation order of the nominated officer would have to be issued by the Ministry/Department concerned.
